I, the above named deponent, do hereby solemnly affirm and declare as under :

1. That the deponent is fully conversant with the functioning of the Company/Firm and competent to depose this affidavit.
2. That the establishment of the deponent viz. M/s Ujjawal Enterprises (hereinafter referred to as the contractor) is an independent legal identity and contractor in accordance with the provisions of the contract Labour (Regulation & Abolition) Act, 1970 having its employees deployed/shall deploy 170 nos. of employees at the premises of M/s B.L.
