



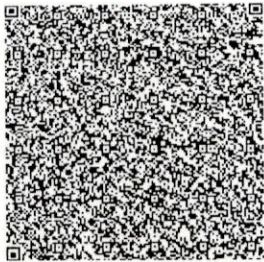

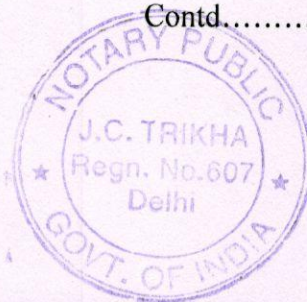
Affidavit of Sh. Sanjay Gandhi S/o Late Shri Ved Prakash Gandhi aged 47 years, MD/Prop./Partner/Owner/HOD/CEO (as the case may be) of M/s Ujjawal Enterprises, 18/611, Joshi Road, Karol Bagh, New Delhi-110005.

I, the above named deponent, do hereby solemnly affirm and declare as under :

1. That the deponent is fully conversant with the functioning of the Company/Firm and competent to depose this affidavit.
2. That the establishment of the deponent viz. M/s. UJJWAL Enterprises (hereinafter referred to as the contractor) is an independent legal identity and contractor in accordance with the provisions of the Contract Labour (Regulation & Abolition) Act, 1970, having its employees deployed/shall deploy 175 nos. of employees at the premises of M/s B.L.K Kapoor Hospital, Pusa Road (hereinafter referred to as the Principal Employer) to carryout Kitchen Manpower work at B.L.Kapoor Hospital, Pusa Road (Place of work).
3. That the deponent has entered into an agreement with M/s B.L.Kapoor Hospital (Principal Employer) on 01-11-16 to carryout above work, which shall remain in force from 01/11/16 to 31-03-17.
4. That the deponent have deployed/do not deploy the worker(s) in the premises/ establishment of the principal employer during the same nature of work which is being done by the worker(s) employed directly by the principal employer.
5. That those workers deployed/shall be deployed by the deponent and performing the same & similar kind of work as being done by the worker(s) directly employed by the Principal Employer are being/shall be paid the same wages/benefits as applicable to the directly employer worker(s) of Principal Employer.
6. That each and every worker deployed by the deponent is/are being/shall be paid not less than the minimum rates of wages fixed for their category of employment under the provisions of Minimum Wages Act, 1948 including overtime/weekly off etc.

7. That the establishment of the deponent is/shall be providing all statutory benefits and maintaining the records under the applicable Labour Laws in respect of all the worker(s) deployed/shall be deployed in the premises of the principal employer.
8. That the process(es)/work/job(s) on which the contact workers are to be deployed is/are not abolished by any Authority or Board.
